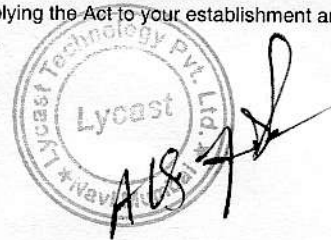




## Declaration in terms of ESIC Registration
